This is the Annual Report for the Friends of Penlee House Gallery & Museum for 2021/22 and the 34<sup>th</sup> year of the Society. This year, for the first time, in the three years since the start of the pandemic, we were able to hold an in-person AGM, which was reasonably well attended given that we had competition from the good weather and an ongoing, but understandable, nervousness of our membership to return to an indoor meeting venue.

At the start of the year, the Gallery experienced another pandemic related closure, but we were able to return to in-person Trustee and Committee meetings from around September, and had been able to continue with online meetings via Zoom from April.

The 'Friends' membership remained healthy with a total of 1713 members made up of 509 single members and 1204 joint members, of which 118 were life members and our income remained healthy as our Accounts show, particularly as we were unable to hold any fund-raising activities to increase it. But we have found that both Friends members and visitors to the Gallery had been very willing to make donations when it has been for a specific purpose such as a painting. And we anticipate that our enhanced online presence will provide a straightforward way for people to make donations, in future. And we have gratefully received unexpected legacies during the year.

We have continued to support the Gallery through the acquisition of paintings and artefacts and we also provided matched funding sponsorship to the Gallery's in-house project and education activities which moved online during the pandemic and included an online version of the *Penlee Inspired* exhibition, plus You Tube videos of children's activities and four successful ten week courses aimed at adults with long-term mental and physical health conditions using the collections at Penlee House to inspire personal creative practice.

The quarterly magazine *Artefact* continued to be a popular publication and we have recently commissioned a project to develop the Friends' online capability as Trustees took the decision that we needed to invest in this as a priority activity as we have very limited online contact with our membership. Unfortunately, our usual programme of monthly Lectures

continued to be cancelled, but we are planning its relaunch in September, although were able to hold a lecture after the AGM, which realistically is the real draw for people to attend the annual meeting.

Sadly, our Vice Chair died in the reporting year, and our President in the 2022/23 financial year but mentioned here as both departures had to be announced at the AGM. The Chair had been due to stand down at the AGM, but the sad passing of the Vice Chair and lack of volunteers to take over the role has meant that they have remained in post beyond the usual three years, although we are actively seeking a replacement, as they do not wish to continue for second three-year term. We are, however, very pleased to report that one of our Vice Presidents, Dr Kurt Jackson, has agreed to take over the role of President following the death of Mrs Elizabeth Bolitho who had been our president since the start of the Friends Society

The sad loss of the Vice Chair and the lack of a 'natural' successor for the Chair, identified a vulnerability in our Constitution of only having a Trustee Board of 'four officers and one other committee member' so the AGM was asked to agree to increase the Trustee Board by two further committee members so that the Trustee Board would operate with seven Trustees, which was agreed unanimously. This amendment required some administrative change to our Constitution document which is recorded elsewhere on the Charity Commission website.

And a number of our long-standing Committee members who had agreed to remain on the Committee during the pandemic, chose to stand down at the AGM, which as reported in last year's report was something that we had been expecting. We have had a reasonably successful recruitment drive this year and have recruited three new Trustees and two new Committee members who were unanimously agreed at the AGM and subsequently approved by the Committee. And we will be looking to recruit a further Trustee and couple more Committee members in the current year to bring us back up to complement, as well as a replacement Chair.

Overall, although 2021/22 started the year with the ongoing pandemic restrictions, we ended the year with an AGM in person and have recruited some new members which we believe will better position us to tackle the changes ahead, although recognise that a new Chair, when they are in place, will rightly bring a fresh approach to the Friends of Penlee House agenda, particularly as we work to support the Gallery and the Friends membership in the future.
