

ANNUAL REPORT OF THE BOARD OF TRUSTEES 2023/2024

2023/4 has seen significant developments for the Friends. We have managed these changes whilst trying to work more economically, reducing the number of meetings and using e-communications more. We held 4 Trustee and 4 Committee meetings, all well-attended. Trustees also had 4 meetings with Penzance Council, as the Penlee House Partnership.

People

We thank staff at Penlee House for their essential support: Anna Renton, Director; Katie Herbert, Curator/Deputy Director; Sandra Paternotte, Administrator; and Maisy-Sky Lumbers, Marketing Assistant. We thank our President and Vice-Presidents for their continuing support. We also thank Sue Wilthew, who became Chair in July 2023, but sadly had to stand down in January 2024, for the expertise and energy which she brought to the role. John Swarbrooke was appointed as her successor. We decided to appoint a second Vice-Chair so that contingencies could be covered, and Ruth Towse has accepted this role.

Once the unincorporated charity transfers to Charitable Incorporated Organisation (CIO) status (subject to decisions at the AGM) there will no longer be a separate Committee. We thank the Committee members who are standing down at this point. We also thank Penzance Councillors who have served on the Committee and look forward to continuing to work with Members through the Penlee House Partnership.

Charitable Incorporated Organisation

Preparing the move to being a CIO has been a large part of our governance work this year. Trustees and the Committee unanimously agreed that this was the right way to enable us to support Penlee House in the future and we wrote to all members in December to describe the proposal. We have followed the Charity Commission template for the new constitution and kept the objects in line with those of the existing charity. The CIO was registered in January 2024. All existing trustees and committee members were invited to opt in to becoming trustees of the CIO. If the AGM agrees to proceed with winding up the existing charity we anticipate that the process will be completed later this year.

Managing our work

Our annual budget cycle is now established, beginning in the autumn with formal requests for funding from the Director. We have also introduced a rolling Annual Plan for our work. We have adopted policies, as recommended in the Charity Commission checklist, on trustees' expenses, conflicts of interest, complaints, health

and safety, grant-making and serious incident reporting, and will continue with this process next year. We reviewed our insurance arrangements and agreed to switch from British Association of Friends of Museum (BAfM) sponsored insurance to Zurich, which offered better cover at a lower price. We decided not to retain membership of BAfM as we were not significantly benefitting from it.

Activities

We have produced three editions of Artefact and our website is under development. We reported last year that we had agreed to contribute half the costs of the new Marketing Assistant post at Penlee House for the first year, with the equivalent of one day per week for work for the Friends. The appointee began work in May and is making a significant contribution to our communications. We have agreed to continue a contribution to the costs of the post until 2026, with the work for the Friends continuing. We are reviewing our communications strategy and the Marketing Assistant will help us to develop the use of social media to engage new members. We have also discussed introducing a patrons' scheme and hope to develop this in the coming year.

Lyn Curnow and Nigel Haward continued to organise the lecture programme. There have been 4 lectures (the number being reduced because of limitations of staff availability at Penlee House) alternating with private openings and other events, including a very successful valuation evening with Barbara Kirk. We are working to expand and vary the programme for 2024/5 including some `field' events. Booking via Eventbrite was introduced in March 2024.

Working with Penzance Council

Meetings with Council representatives are now well-established and help us to understand how the Council sees the future for Penlee House and to voice our views. Since 2016/7 the Friends have held a fund amounting to £8400 collected through an appeal for a capital development project which did not proceed. The Council asked for consideration of the use of this as a contribution to a proposed new Learning Centre for the Gallery and Museum (phase 2 of the Penlee House masterplan). All donors were contacted for permission to use their contributions in this way. The Trustees agreed to round up the sum to £10,000 to cover the costs of the phase 1 feasibility study for this project. The study will be carried out in 2024/5. We thank James Hardy, Penzance Town Clerk, for his support for our partnership.
